Alongside, with the energy market opening up in India and Bangladesh, Nepal is coming up with a comprehensive energy development program to develop 30000 MW of electricity by 2035. The country's existing generation capacity is around 2800 MW with several projects under construction to generate an additional 5000 MW (Source: *The Kathmandu Post*, 13.09.2023). Towards the end of 2023, 95% of Nepali households have access to electricity from on-grid and off-grid sources. In a nutshell, Nepal is going to be a hub of power generation, energy trade and consumption alongside.

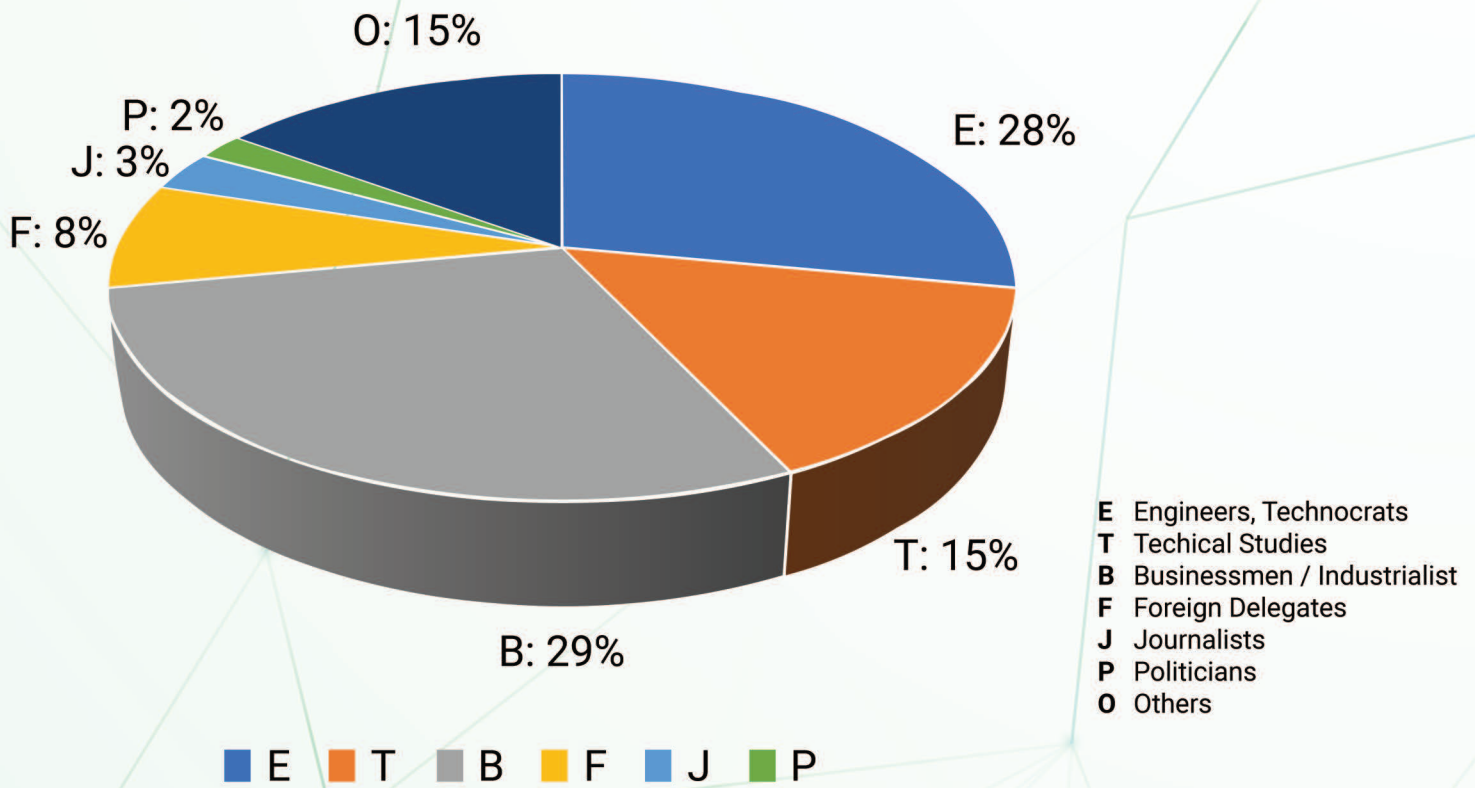

Terms & Conditions

3. The "Stand" means the space or area and including the structure thereon known as the shell stand allotted to the Exhibitor, the size of allotment being specified in the contract.
4. Exhibitors are requested to limit themselves within the space area allotted to them. Disturbing or encroaching space beyond the space allotted is strictly prohibited.
5. The stall booking cannot be confirmed until the Full Payment is received. Failing to pay the balance amount (if any) within one week of signing this contract will void the participation with no refund of the advance payment.
6. In case the event is cancelled, the liability of the Organizers is limited to refund the rent paid by the exhibitor.
7. As the number of stalls are limited, the Organizers reserve the right to accept the offer, to revise the layout and the allotment of stalls.
8. The Organizers shall not be responsible or liable to the exhibitor or to anyone at the stand or in the exhibition hall for any accident happening or injury suffered or for any damage to or loss of any chattel/merchandise sustained in the areas of the exhibition.
9. Although maximum security measures will be followed, the Organizers will not be responsible for any theft, damage or unforeseen calamities in the premises. If you require insurance policy you are requested to do the same through your insurer.
